
The U.S. Environmental Protection Agency (EPA) has reviewed the above-referenced document pursuant to the National Environmental Policy Act (NEPA), Council on Environmental Quality (CEQ) regulations (40 CFR Parts 1500-1508) and Section 309 of the Clean Air Act. EPA provided comments on the Draft Programmatic Environmental Impact Statement (PEIS) on May 3, 2007. We rated the Draft PEIS as Environmental Concerns – Insufficient Information (EC-2) and encouraged the U.S. Fish and Wildlife Service (USFWS) and the U.S. Army Corps of Engineers (Corps) to consider project impacts on the ambient level of the 24-hour standard for Particulate Matter with a diameter of 2.5 microns or less (PM_{2.5}), locally and regionally, in the Final PEIS. Our comments on the scope of NEPA compliance and programmatic and project level air quality conformity were resolved in the Final PEIS. In addition, our recommendations to further reduce impacts from diesel particular matter and mercury entrained dust emissions were incorporated into the project.

Since reviewing the Draft PEIS for this project, the state of California has recommended designating the San Francisco Bay Area as non-attainment for the PM_{2.5} 24-hour standard. Based on the state's recommendation, it is likely that the entire San Francisco Bay Area will be designated as non-attainment for PM_{2.5}. Final designation is expected by December 2009 and would be effective by April 2010. As a result, conformity would be required during project implementation. Considering the long term nature of the project, EPA recommends reviewing the new state implementation plan (SIP) that would be prepared (anticipated by April 2013) to identify how it applies to the project and to incorporate reasonable measures and mitigation approaches to address project PM_{2.5} emissions.
